STRATEGIC OUTCOMES PER STRATEGIC AREA

1. Enable Operational Environment

a. Deepening understanding and inspire action on critical sector issues

- i. 2018 started with research on the Universal Periodic Review (UPR). In collaboration with CIVICUS, NNNGO conducted research on human rights situations in Nigeria relating to civic space.
 - Made report submissions on the 2018 UPR in Nigeria on civic space
 - A UPR advocacy strategy workshop was conducted using the **SMART advocacy tool**.
 - A workshop report was developed on strategies organisations can adopt to advocate to the government to adopt the UPR recommendations.
 - Created awareness on the UPR using infographics and bulk SMS.
 - Participated in UPR Advocacy and lobbying via disseminating letters to various Embassies in Nigeria.

- ii. Executed an OSIWA sponsored project on Civic Engagement on the Financial Action Task Force (FATF) Evaluation of Nigeria. The project:
 - Anti-money laundering act and bill reviewed and developed into a research report
 - Carried out sensitization on FATF and its recommendations amongst civil society. Weekly bulk SMS, 2 social media creatives published on FATF with 2,759 Fans reached; 15 FATF focused e-newsletter developed and circulated to

2,377 civil society organisations; 4 Op Ed published in the Punch Newspaper and 2 online via the NNNGO website.

- Participated in 5 targeted engagement meetings. 4 targeted engagement meetings held with NFIU and SCUML; 1 face-to-face meeting with Special Adviser to the Senate President on NGOs and Clerk Senate Committee on CSOs and Diaspora; Also participated in an inter-ministerial committee workshop organised by NFIU.
 - Formed an informal coalition of civil society organizations interested in working on FATF related issues. Conducted 4 meetings (2 online and 2 physical) with 145 civil society organisations subscribed to the membership of the coalition. NNNGO first WhatsApp group of 130 members was created for the coalition for real time information. NNNGO also attended six online global NPO coalition meetings and one webinar to learn and share best practices.
 - Conducted 2 regional workshops in Lagos and Abuja with 135 participants from 14 states attending.
 - Convened a sector wide conference on 28th March 2018 with over 200 participants in attendance.

 - Developed a capacity needs assessment survey for online and offline use – known as the Non-profit Self-Assessment Tool (NOPSAT)
 - Organised a validation workshop in Lagos on June 3 2019 with 72 member-organizations drawn from 8 states and the Federal Capital Territory (FCT)- Abuja attending.
 - Developed a capacity needs assessment report based on the outcome of the Non-profit Self-Assessment Tool (NOPSAT) and the Validation workshop
 - 51 infographics developed and posted on the NNNGO Facebook page on the Istanbul Principle and 6 info-graphics on the non-profit self-assessment.
 - Developed a standard operational manual for nonprofits
 - Organised 2 capacity building workshops in Lagos (with 54-member organization in attendance from Lagos and Oyo) and Abuja (with 84 participants in attendance, drawn from 8 states and the Federal Capital Territory -Abuja) based on the identified gaps on the assessment report.

b. Protecting nonprofits from abuse and mismanagement

 - 15 participants on November 15, 2021, attended a virtual training to guide participants through the project workplan and share the analysis of the capacity assessment survey and validate it.
 - 14 nonprofit leaders were physically present in the capacity building workshop for sub-national networks/ coalitions in Abuja November 23, 2021.
 - 10 hybrid (physical and virtual) workshops to strengthen capacity were held with 322 participants attending in total across the 10 project states.
 - 9 (Abuja, Edo, Lagos, Rivers, Enugu, Kano, Adamawa, Sokoto and Plateau) states held dialogue sessions between MDAs, CSOs and relevant stakeholders with 267 participants in attendance.
 - A draft harmonisation bill and a policy framework on one-stop-shop was developed by the project for review and validation by the EU-ACT project team and civil society organisations in Rivers and Enugu State. The one-stop shop policy has been developed for use by policy makers in Sokoto. These three states at the close of the project have advanced in their consultations and dialogues to the level of considering Bills and policy towards harmonisation.
